### Chocolate Oatmeal Cookies

3 cups Quick Oatmeal  
2 cups Sugar                      ½ cup Peanut Butter  
½ cup Milk                        ½ teaspoon Vanilla Extract  
½ cup Cocoa                      1 stick Margarine

In a small pot mix sugar, milk, butter and vanilla. Let boil for about 1 to 2 minutes. Add oatmeal, cocoa and peanut butter. Mix well. Drop on wax paper. Makes 15 to 20 cookies.

### PAC 400

\$25.99 a month with 400 FREE long distance minutes; 6¢ per minute for the next 200 minutes.\*

### PAC 600

\$35.99 a month with 600 FREE long distance minutes; 6¢ a minute for the next 200 minutes.\*

\* For PAC Nationwide, any minutes in excess of 600 monthly are priced at 0.11 per minute. For PAC 200, PAC 400 and PAC 600 minute plans, any minutes 201 or more over the minutes included free within your plan are priced at 0.11 per minute.
